Dear Coach/Manager:

On behalf of the South Muskoka Minor Hockey Association, I would like to extend this invitation to participate in our annual **Bantam AE / Minor Midget, O.M.H.A. Rep. Minor Hockey Tournament**. The tournament date is December 6<sup>th</sup>, 7<sup>th</sup> 2013.

This tournament is sanctioned by the O.M.H.A. and is subject to the Tournament Regulations issued by the O.M.H.A. Managers will be required to show approved O.M.H.A., or equivalent, branch registration documents, for all players and team officials, at the time of team registration at the tournament.

The tournament will be arranged as follows:

- 1) Four Bantam AE and four Minor Midget teams will be accepted by the Tournament Committee, however, the committee reserves the right to accept, or reject, any team.
- 2) Three games are guaranteed, with a possible fourth being a semi-final game, and a possible fifth being a championship game.
- 3) The entry fee is \$800.00 per team and must accompany your application. Please make your cheque payable to: **South Muskoka Minor Hockey Association**. Please be advised that there will be no gate fee.
- 4) Games will be played in the Bracebridge arena.
- 5) Champions and Finalists of the championship game and consolation championship game will receive awards.
- 6) Application for entry to the tournament will be dealt with on a first come, first served basis (no exceptions).
- 7) Generally teams accepted will be limited to those that fall into O.M.H.A. classifications AE3 to AE5 and A to C although the Tournament Committee reserves the right to accept a team from a lower classification.
- 8) Acceptance of your team will be confirmed by e-mail, fax, or letter. Your team's entry fee cheque will be cashed immediately.
- 9) If a team withdraws prior to 20 days before the start of the tournament, the entry fee will be refunded only if a replacement team can be found. If a team withdraws within 20 days of the start of the tournament no refund will be given even if a replacement team can be found.
- 10) Tournament Schedule will be available approximately 1 week prior to the first day of the tournament.

Please print a tournament entry form and a copy of the SMMHA Tournament Rules and Regulations. Please complete the entry form, and return with your entry fee. Player lists should be submitted as soon as possible, but not later than 14 days prior to the tournament date. If not registered with the O.M.H.A., a travel permit is required and must accompany the entry form.

TOURNAMENT RULES AND REGULATIONS  
December 6<sup>th</sup>, 7<sup>th</sup> 2013**

1. This tournament is sanctioned by the O.M.H.A. and all O.M.H.A. Rules and Regulations apply.
2. Games will be played in the Bracebridge arena.
3. All managers and bench staff must report to the tournament office at least one hour prior to their game to sign game sheets and have bench staff sign sheets.
4. Team rosters will be limited to 19 players, including goalies.
5. Teams should bring two (2) sets of sweaters, one dark (Visitor) and one light (Home).
6. The "Home Team" will be designated on the tournament game schedule.
7. In case of conflicting sweater colours, the designated "Home Team" will change.
8. All teams will play four (4) games.
9. All teams must be prepared to take to the ice fifteen (15) minutes prior to their scheduled time.
10. Games will consist of three 10 minute stop-time periods.
11. Flooding will be at the end of each game of the tournament.
12. There will be four (4) Bantam AE teams and four (4) Minor Midget teams with each team playing three (3) preliminary games and a final or consolation game determined by point standing.
13. Preliminary Games will be scored using the points per period format:
  - ☐ 4 points for a win
  - ☐ 2 points for every period won, and for a tied game
  - ☐ 1 point for every period tied
  - ☐ 0 points for all periods and games lost
  - ☐ Total points available to be won: 10 per game
14. If teams are tied then the following tie breaking format will be used to determine which team will have the higher placing:
  - ♦ If a two way tie, then the winner of the game between the two teams.
  - ♦ If still tied then the team with the highest resultant from goals for divided by goals against.
  - ♦ If still tied then the team with the lowest total penalty minutes, including a mercy rule adjustment.
  - ♦ If a three way tie then the team with the highest resultant from goals for divided by goals against.
  - ♦ If still tied, then the team with the lowest total penalty minutes.
15. **TIED ROUND ROBIN GAMES:** One (1), five minute sudden-victory overtime period during which teams will play three on three plus their goaltender. If still tied then each team is awarded 2 points. Penalized players will serve their time and the team with the power play will add a 4<sup>th</sup> player.
16. The first and second placed teams will advance to the Championship Final and the third and fourth placed teams will advance to the Consolation Final.
17. **TIED FINAL GAMES:** If tied after regulation play there will be a five minute sudden-victory overtime period during which teams will play three on three plus their goaltender. Penalized players will serve their time and the team with the power play will add a 4<sup>th</sup> player.  
If still tied, a shoot-out will be utilized to determine the winner (see shoot-out rule).

18. Every player and team staff member receives an award. Each team will pick their own MVP for each game except the consolation and Championship games which you will pick the other teams MVP. MVP medals will be handed to the manager when they sign the game sheet prior to each game.
19. **Any fighting penalties will result in immediate suspension from the tournament, of the player(s) or staff involved.**
20. **One Time-Out is allowed per team during the Consolation and Championship Games only. (Not during Round Robin Games)**
21. **Mercy Rule:** If there is a 5 or more goal differential between teams at any time during the third period of any round robin game, the remainder of the game shall be played as straight time even if the goal differential becomes less than 5. After the commencement of straight time, minor penalties will be 3 minutes in duration and majors will be 7 minutes. Minor penalties assessed during straight time will be adjusted to 2 minutes for tie breaker purposes and majors to 5 minutes.
22. All decisions of the SMMHA Tournament Director, or in his/her absence the Bantam AE or Minor Midget Tournament Convenor, are final.

#### **SHOOT-OUT RULE:**

1. Shoot-outs only apply in the Final games.
2. Each coach will appoint three players as shooters.
3. Shooters will alternate with the home team beginning first.
4. If one team scores on its first 2 shots and the other team does not score any goals on its first 2 shots, then the third shooter is not necessary.
5. **If still tied after 3 shooters**, the Coaches will appoint another shooter, **then it becomes a sudden-victory shoot-out.** The first team to score when the other team does not, shall be the winner.
6. No shooter may repeat until all skaters have taken their turn.
7. Shooters must maintain the order of the first round if a second round is necessary.
8. All applicable sections of the CHA Penalty Shot rule shall apply during shoot-outs.
